# 1EdTech Conformance Certification Process and Branding Guidelines

This document explains the 1EdTech<sup>®</sup> Consortium certification process and branding guidelines for using the 1EdTech TrustedEd Apps<sup>™</sup> Certified logo and other trademarks.

1EdTech conveys our brand strength through the design and use of our logos. 1EdTech Contributing, Affiliate, and Alliance Members also benefit from associating with the 1EdTech brand. These guidelines describe how to display the certification logo in a consistent manner that strengthens brand recognition and identity for 1EdTech and its members.

## 1EdTech TrustEd Apps Certified Logo

1EdTech provides a certification logo to members with certified products to display on their websites and other marketing materials.



1EdTech's TrustEd Apps Certified logo identifies systems and content that have achieved official 1EdTech conformance certification through proper testing and authorization processes developed by 1EdTech members for specific versions and profiles of 1EdTech specifications.

After 1EdTech grants your product certification and issues a registration number, you may use the 1EdTech certification logo for one year as long as your 1EdTech membership is active, and you agree to the <u>license online</u>. You may continue to use the certification logo after one year if you recertify your product (an annual requirement for most specifications) and retain an active 1EdTech membership.

The certification logo should not be redesigned, embellished, or combined with other identifiers.

1EdTech has a rigorous vetting process for data privacy policies. Your certified product will be available to be vetted with the results shown in the 1EdTech TrustEd Apps Directory. Going forward, you will be the point of contact to review any submissions (if necessary) unless you directly appoint someone else to fulfill that role. # **1EdTech Certification Policy and Process**

1EdTech provides a series of tests to check both files and systems for conformance. These tests are based upon the requirements indicated in a specification. The Test Systems are periodically updated to add features, enhance the test framework, and correct mistakes.

#### **Conformance Certification Suite Updates**

1EdTech will send a notification and post changes when any 1EdTech conformance test is updated. The notification will include what test system has been changed or updated, the nature and extent of the change, and the expectations of the conformance-certified organizations impacted by the change.

### Conformance Certification Yearly Re-Testing

All 1EdTech Conformance Certifications will be active for one year from certification testing. As both products and the certification suite evolve, good practices dictate that organizations re-test your products yearly to ensure that they accurately meet the requirements outlined in the specification.

Notifications will be sent to members 60 days and 30 days before your one-year certification expiration with a request to retest your product. Products not re-tested and recertified will be considered inactive and removed from the TrustEd Apps Directory.

## Conformance Certification Re-Testing Due to Errors/Omissions

While the tests are designed to be complete, an occasion may arise when an error or omission in the test has occurred. If an error or omission has been found in a 1EdTech conformance test, the following items will be taken under consideration on whether or not organizations must retest their systems/files to maintain their conformance designation.

- 1. The Product Steering Committees (PSC) responsible for managing conformance on the specification will review the error and categorize the severity of the problem.
- 2. If the severity of the problem will not significantly hinder interoperability, a notification will be sent to all conformant organizations, indicating the problem and suggesting they retest their systems/files. A retest will not be mandatory. The test system will be updated, fixing the problem, and a notification will be posted in the test details.
- 3. If the severity of the problem will significantly hinder interoperability, the PSC may deem it necessary for all systems/files to be retested. Notification will be sent to all conformant organizations with a timeframe to retest their systems/files. A retest will be mandatory to maintain a conformance designation.
- 4. A testing date will be added to the 1EdTech conformance registry so that consumers will be aware of the time and test system version under which the conformance was issued.

# Standards Deprecation and Certification

Occasionally, standards are deprecated as new versions are released. Depreciation schedules are posted on the 1EdTech website. The depreciation schedules include the dates for which certification for an older version of a standard will be accepted. 1EdTech will stop offering certification for deprecated standards as dictated by the schedules.
